Boom Logistics Limited (the Company) is pleased to announce the appointment of Mr Jean-Pierre Buijtels as a non-independent non-executive director to the Board of Directors effective 2 June 2017. Mr Buijtels fills a casual Board vacancy and as such will stand for election at the next Annual General Meeting.

Mr Buijtels' appointment is supported by Rorema Beheer BV, manager of the fund Gran Fondo Capital in which Mr Buijtels holds the position of portfolio manager. Rorema Beheer BV (through the fund's depositary Stichting Bewaarder GFC) has held shares in the Company since August 2014 and presently holds 14.9% of the issued capital of the Company.

Mr Buijtels has shown a long term commitment to the Company through a period of significant transformation. Mr Buijtels' knowledge of corporate finance and the crane business in Europe is expected to improve the Company's access to those markets for the sale, purchase and lease of crane assets by the Company. Mr Buijtels' background in investing in private equity and public equity is expected to positively enhance the Board's overall skills and experience.
