Please find attached an Appendix 3X in respect of the appointment of Mr Jean-Pierre Buijtels as a Director of the Company.

The Company refers to the market release dated 2 June 2017 in relation to Mr Buijtels' appointment to the Board, and Mr Buijtels' relationship with Rorema Beheer B.V., which is a substantial holder of the Company via Stichting Bewaarder GFC.

Mr Buijtels has made the following disclosures to the Company:

Mr Buijtels is employed by Rorema Beheer B.V., the fund manager (the Fund Manager) of the fund Gran Fondo Capital (the Fund) which holds 70,760,675 shares in Boom Logistics Limited (the Company). Mr Buijtels' remuneration is partly linked to the performance of the Fund, which is influenced by the performance of the shares of the Company as long as the Fund holds shares in the Company. Mr Buijtels holds a minority economic interest of less than 5% of the units of the Fund and thereby indirectly an economic interest in the Company as long as the Fund holds shares in the Company. The Fund is open-ended and Mr Buijtels can redeem his units in the Fund against their net asset value minus redemption fee at each transaction day of the Fund.

Mr Buijtels is not a director of the Fund Manager, and does not have the power to exercise votes, control the exercise of votes, dispose of or control the disposal of the Fund's shares in the Company. However, he can influence the decision-making process of the director of the Fund Manager in his capacity as its portfolio manager.
